**Storm Recovery-** Insurance paid out \$3804.74 for storm costs to be distributed to cost centers impacted: \$158.34

Park Fund, \$75.00 township building maintenance, \$522.02 Water Department, \$3049.38 Cemetery.

Final FEMA payment of \$12,425.09 expected. To be put in Water Fund when it arrives.
