Payables: Motion by Trustee White, second by Supervisor Werner, to pay payables of \$6,322.80

Public Comment: Legion Post #201 would like to take over the Memorial Day Parade from the Chamber. The Township procures the parade permits when asked, but does not regulate or supervise parades. Encouraged Legion to get with Chamber to iron out the details. No Board action at this time.

Old Business:

Security Cameras: Still investigating, need to find room in budget.

Auditor- After a search for Auditors, Supervisor found one for \$24,000/ Year. In the meantime, our past auditor agreed to take us back under the wing using previous contract language. Motion by Supervisor Werner, Second by Trustee White to keep Straley, Lamp, and Kraenzlein as auditors as long as cost does not exceed budget.

New Business:

Water Improvements- MWRA will be doing a rate study in April, Maps have been sent to NEMCOG for digitizing. Clerk working with Mi Infrastructure council to find grant fits.

Run Water notice- Just making it clear that run water notice has expired.

Dock Bath Gas Meter- Found out we have been paying for gas meter/service where there is no appliances for using Gas. Have asked PIE&G to remove meter.

Cemetery Trailer/Gas service- Found Township has been paying rental on propane tank at the Cemetery that is not used. Pulled out of weeds, scrapped off moss, called for pickup. Amerigas came and got the tank and closed account. The tank was mounted to a small trailer with flat tires, Not usable for any purposes at township. Motion by Supervisor Werner, Second by Clerk Green to scrap/dispose of trailer. Motion Carried.

Early Voting Location- Clerk presented Resolution #19 of 2023 which is an undated resolution agreeing to allow Early Voting for the County. Just presenting to Board to make them aware of previous agreement. No changes noted, no action needed by Board.

Budget Adjustments- Clerk presented Budget adjustments for 25-26 Fiscal Year.

Motion by Supervisor Werner, second by Treasurer Werner to approve the following adjustments:

\$200.00 from 101-257-702 to 101-257-900, \$100.00 from 101-702-826 to 101-702-860, \$1000.00 from 101-702-826 to 101-702-712, \$400.00 from 101-701-826 to 101-701-860, \$1200.00 from 101-441-931 to 101-441-714, \$550.00 from 101-441-931 to 101-441-717, \$350.00 from 101-262-728 to 101-202-931, \$1600.00 from 101-261-707 to 101-261-712, and \$1100.00 from 591-536-732 to 591-536-818.

Jerome Street- Time to discuss Road Priorities for upcoming building season. Another location to look at is West Lake 15 Road. Supervisor to contact Road Commission for costs/ scheduling.
